Right to Know and Access Information

You have the right to request, at no charge:

 - Categories of personal information include: identifiers; personal information categories listed in the California Customer Records statute (Cal. Civ. Code Section 1798.80(e)); protected classification characteristics under California or federal law; commercial information; biometric information; internet or other similar network activity; geolocation data; sensory data; professional or employment-related information; non-public education information (per the Family Educational Rights and Privacy Act (20 U.S.C. Section 1232g, 34 C.F.R. Part 99)); and inferences drawn from other personal information.
 - For visitors who have ad personalization turned on in their browser(s), Grand Bank currently may collect: demographic information and interest information, such as age, gender, and interests; cross-device activity to better understand the customer journey across devices (including the browser used); user ID and device ID, which helps with marketing.
- The sources from which personal information is collected.
- The business or commercial purpose for collecting or selling your personal information.

Right to Correct Information

You have the right to request correction of your personal information if you believe it is inaccurate.

Exclusions

Verification Process

We will verify your identity using information you provide and match it against information already held by us. For requests pertaining to specific pieces of personal information, additional verification steps may be required.

Response Time

For verifiable consumer requests, we will acknowledge receipt of your request as required by applicable law, as well as inform you of the timeline to complete the request. If the request is to opt-out, we will respond no later than 15 business days after receipt of your verified request. We aim to fulfill verified requests within 45 calendar days of receipt. If we reasonably require more time (up to an additional 45 calendar days), we will inform you of the reason and extension period in writing.
